



Oversight, Judiciary, and Ways & Means committees release report how Biden and family got rich from socialist agenda

Oversight, Judiciary, and Ways and Means Committees Release Report on Impeachment Inquiry Finding Joe Biden Has Committed Impeachable Conduct

WASHINGTON— On August 19, 2024, the House Committee on Oversight and Accountability, Committee on the Judiciary, and Committee on Ways and Means released a report on the impeach-

Trump exposes the truth about Social Security for immigrants and how it affects elderly and low-income

During the first presidential debate, Donald Trump claimed the Biden-Harris administration is "trying to put [illegal immigrants] on Social Security."

"Fact checkers" immediately swarmed to debunk the former president. The problem here is that he's largely correct.

When most people think of Social Security, they envision the main retirement benefit for seniors. But the Social Security Administration actually operates several programs for elderly, disabled, and the low-income. While foreigners who cross the border illegally generally don't qualify for retirement benefits, they can receive substantial cash payments from other Social Security programs.

In particular, foreign nationals can qualify for Supplemental Security Income (SSI) -- the Social Security program designed to assist people with little or no in-

Legal immigrants such as green card holders and refugees can qualify for SSI.

But crucially, other foreigners can also qualify -- including those who came here without visas but who received a temporary reprieve from deportation. Eligible foreigners include parolees, Cubans, Haitians, Afghans, Ukrainians, and migrants who've been granted conditional entry or asylum.

Admittedly, not everyone from those groups qualifies. Those foreigners generally also must have resided in the United States for a certain amount of time, or have married a member of the U.S. military, or claim to be victims of human trafficking.

But even with those additional delays and qualifications, nearly 325,000 noncitizens received SSI benefits in 2023, according

to preliminary estimates from the Social Security Administration.

That number could rise even higher, once the parolees and other foreigners who've entered under the Biden-Harris administration have lived here for a certain period of time.

So far, the administration has paroled at least 462,100 Cubans, Haitians, Nicaraguans, and Venezuelans into the United States, as

well as 187,000 Ukrainians and tens of thousands of Afghan nationals. Many of them could ultimately receive SSI benefits -especially if a future Harris administration relaxes the criteria needed to qualify.

And of course, Social Security is hardly the only government program that foreigners -- including illegal immigrants -- are tapping

Data from the Survey of Income and Program Participation indicate that 59% of noncitizen households -- a classification that includes both legal and illegal immigrants -- utilize at least one major welfare program. By comparison, only 39% of U.S.born households rely on welfare programs. Noncitizen households are receiving everything from Medicaid and Supplemental Nutrition Assistance Program (SNAP) benefits to welfare for their U.S.-born children, school breakfasts and lunches, and earned income tax credits.

Democrats haven't shown signs of backing off, either. On January 1, California became the first state to offer all low-income illegal immigrants health coverage through Medi-Cal, the state-run health insurer.

Trump's warning about Social Security wasn't hyperbole. Congress needs to comprehensively review America's immigration policies and benefit programs to ensure they serve the interests of U.S. citizens.

Soros spends \$117 million to 'elect, control leftist county prosecutors throughout U.S.'

In a scheme to promote a radical leftwing overhaul of the U.S. justice system, billionaire George Soros has spent about \$117 million in the last few years to elect then control dozens of liberal county prosecutors throughout the nation, a new report reveals. Once elected the prosecutors, typically known as district attorneys who represent the government in criminal cases, meet

regularly with representatives from Soros-funded nonprofits that coordinate and manage the chief officials responsible for upholding and enforcing the law in their respective districts. The Soros machine orders prosecutors to practice leftist policies that are soft on crime, target police and political opponents. The district attorneys are also directed not to enforce certain laws such as those protecting children from chemical castration and genital mutilation, procedures justified by the left as "life-saving genderaffirming" for transgender indi-

The extraordinary details of the robust Soros effort to overhaul the nation's justice system by embedding leftist prosecutors throughout the country were uncovered during a year-long investigation by the Media Research SOROS SPENDS \$117 MILLION TO ELECT, CONTROL LEFTIST COUNTY PROSECUTORS THROUGHOUT U.S. Judicial Watch CORRUPTION CHRONICLES

Center (MRS). Dedicated to documenting and combating the falsehoods and censorship of the news media, the Washington D.C.-based group examined thousands of pages of documents that show a "shocking level" of control by the Soros-funded nonprofits over many county prosecutors. "The Soros machine sets their policies and priorities, staffs their offices with hand-picked leftists, dictates media narratives, lobbies government officials and perverts the American justice system," the MRC probe found. The investigation determined that the Soros enterprise dedicated at least \$40 million to help elect 126 prosecutors and an additional \$77,663,316 to the leftist nonprofits that issue their marching orders once they are in office.

MRC used public records requests to obtain 7,785 pages of internal communications from dozens of Soros-backed prosecutors and examined official files as

well as electronic mail, text messages, chats, and other communications. The documents expose how the Hungarian billionaire's groups directed the liberal prosecutors to manipulate laws involving drugs, abortion, illegal immigration, election integrity, capital punishment and even childhood sex changes. One of the key groups directing the local prosecutors is Fair and Justice Prosecution (FJP), a nonprofit committed to promoting a justice system grounded in fairness, equity and compassion. "Great strides have been made in promoting justice reforms that recognize that prior 'tough on crime' and incarceration-driven practices have not always resulted in safer or healthier communities," according to FJP. The group is a sponsored project of the Tides Center, another Soros-funded conglomerate dedicated to advancing social justice. "FJP held at least 51 private meetings and

published 33 formal statements and pledges that contained signatures from prosecutors within its network between 2021 and 2022 alone," the MRC report states.

Examples include 508 communications—emails, virtual meetin-person conversations—between Francisco District Attorney Chesa Boudin's office and FJP during an 18-month period, averaging at least one communication a day. Five county prosecutors in Texas worked so closely that they created a shared group chat to strategize on refusing to enforce statutes that ran afoul of their leftist political views. Combined the elected officials represent

over seven million Texans and the documents reviewed by MRC show they strategized to undermine political opponents, including the state's Republican attorney general. "At least 30 percent of the U.S. population currently lives under the boot of the Soros prosecutors who were pressured to sign pledges vowing to adhere to various Soros prior-

Besides embedding likeminded county prosecutors nationwide, the records obtained by MRC show that Soros also spent at least \$35 million to support anti-police groups and causes in one year alone after George Floyd's death.

ities," the report says, adding that the "Soros machine" arranged dozens of joint statements and pledges signed by 123 of the 126 prosecutors vowing to adhere to the leftist billionaire's priorities. Besides embedding like-minded county prosecutors nationwide, the records obtained by MRC show that Soros also spent at least \$35 million to support antipolice groups and causes in one year alone after George Floyd's death. His beloved FJP defended the violence and racial unrest triggered by the Black Lives Matter (BLM) and Antifa movements, accusing the American criminal justice system of being systemically racist. Soros's Open Society Foundations (OSF) also dedicated \$220 million for racial justice and black empowerment in the aftermath of Floyd's death.

The real question is 'Who is Kamala Harris?' a view from Judicial Watch

The world will quickly be getting to know presumptive Democratic Party presidential nominee Kamala Harris. Her long relationship—personal political-with the scandalscarred California power broker Willie Brown is instructive. Brown was instrumental in Harris's rise in California politics. In return, she may have protected him and his allies from damaging investigations.

Brown rose through the ranks of the California State Assembly and became Speaker in 1980. He served in that post for fourteen years, ruling with an iron fist in a velvet glove, rewarding allies with lucrative patronage posts and punishing opponents. He called himself the "Ayatollah of the Assembly." In 1996, he was elected mayor of San Francisco, serving two terms. Along the way, he attracted the attention of the FBI, which repeatedly investigated him but failed to bring charges.

The FBI may have failed, but Brown had plenty of critics. "The legacy of Willie Brown has been one of corruption and incompetence in government, and the [FBI] probes were a reflection of that," the head of San Francisco

It was not the first time Willie Brown had given Kamala Harris a helping hand. The two dated in 1994 and 1995. In 1994, Brown appointed the then-obscure county prosecutor to two influential state commissions—the Un-

Board and the California Medical Assistance Commission. Harris's political rise was launched elected DA in 2003 and 2007, California Attorney General in 2010 and 2014, United States Senator in 2016, and Vice President in 2020.

Questions persist about what Harris may have done for Brown and his allies. The investigative journalist Peter Schweizer noted in a recent interview with Breitbart that in her first DA race, Harris ran against the incumbent prosecutor, who was investigating corruption allegations against Brown. "And when she won," Schweizer said, "she dropped a whole series of cases" connected to Brown.

The biggest case, Schweizer said, involves an 800-page document from the diocese of the Catholic Church in San Francisco detailing accusations of sexual abuse linked to "individuals and entities" with connections to the Democratic Party. And it has been reported in San Francisco, that document disappeared and never was to be found."

Farm bill is gift to China and national security threat to USA; EATS Act is a China Trojan Horse

Many of you saw in a recent Dr. Phil interview with former US President Trump the alarming issue with Chinese Communists buying strategic swaths of land around US military bases. This is not the only land-based threat the Chinese Communists pose from within America's borders. In the landscape of modern warfare,

China has already set its sights on our food supply, and alarmingly, many Americans, ncluding elected officials fail to recognize the Trojan Horse that's in our backyard China and our other adversaries are not just aiming at our military infrastructure but at the everyday essentials we take for granted like our food. Our food supply stands as a glaring vulnerability—a weak point that, if compromised, could thrust our society into utter chaos. China has already set its sights on our food supply, and alarmingly, many Americans, including elected officials, fail to recognize the Trojan Horse that's in our

backyard. Now, it's gone from the shadows to inside the House of Representatives' Farm Bill.

The Farm Bill—recently passed out of the House Agriculture Committee—contains language known as the "EATS Act," an altered version of H.R. 4417, led by Rep. Ashley Hinson, R-IA. This insidious clause gifts Chinese-owned Smithfield Foods more control over our agriculture at the expense of states' rights and America's farmers. Surprisingly, members of my own party are pushing it.

Here's what the EATS Act would do: It eradicates state and local control over agriculture, allowing foreign conglomerates to operate without restriction in our communities. If the EATS Act eliminated state and local authority over agriculture, it would allow companies like Smithfield Foods to synchronize their American production practices with how they do it in China.

In China, so-called pig skyscrapers are commonplace. These facilities resemble industrial sized wet markets where hundreds of thousands of pigs are crammed together on each floor. Such places are rife with diseases from daily pig waste and could be where our ongoing avian flu crisis jumps to pigs and then humans. In an April 2020 report based on a three-year study, the Animal Welfare Institute identified Smithfield Foods as one of the worst slaughter plants in the US, which explains their preference for reduced oversight that

Consolidation is also a major threat to our food supply. The hog farming industry in Iowa has seen significant consolidation over the past few decades, leading to a decrease in the number of small, independent farms. Most of Iowa's hog farms disappeared between 1982 and 2017 due to the expansion of large factory farms, known as Concen-Animal Feeding Operations (CAFOs). This trend has continued, with one-third of the remaining small hog farms in Iowa disappearing from 2007 to 2017. Four companies control 60% of the pork industry, with China's Smithfield Foods being the largest. Hog farms in Iowa are under its control, either directly or through contracts. If Smithfield Foods could operate without restriction, it would con-

sume the remaining traditional

and multi-generational American

pork producers. The more we let our supply chains become consolidated the more they are vulnerable to Chinese direct supply chain disruptions and cyberattacks. A 2021 ransomware attack on JBS, a Brazilian company, who controls a fifth of America's beef industry, forced them to temporarily close production facilities in Australia, Canada, and the United States. Another cyberattack in 2021 threatened to impact 40% of all grain producers in the country who used the same software. We all know that China actively engages in cyber warfare. Why then would we allow China to put our food supply at risk and give them more direct ways to attack the sustainability of our nation? If China's Smithfield Foods gets

its way and the Farm Bill passes with the EATS Act intact within it, we are facing a ticking time bomb that will irreversibly change rural America and threaten our food security. That's why I am disheartened that so many Republicans have not vocally opposed this Farm Bill provision and why I am equally dismayed by those who seem blind to the Chinese threat to our food supply.

I am troubled by Rep. Ashley Hinson from Iowa's 1st Congressional District for her stance on food control, potentially providing China with a path to monopolize America's food industry. Iowa's 1st Congressional District,

"Congress must do everything in its power to help strike the terrible EATS Act language included in the House Farm Bill that would decimate producers across the U.S. and nullify countless state and local laws designed to protect small and midsized farmers," said Marty Irby, president and CEO at Competitive Markets Action and Capitol South, LLC, who represents Moms for America on Capitol Hill. "This radical assault on American family farmers by the global meat cartel and Members of Congress who support them should have every farmer, mother, and American voter up in arms."

In March, 10 U.S. House Republicans, led by House Freedom Caucus (HFC) champion Rep. Anna Paulina Luna, R-FL, sent a letter that included HFC chairman Bob Good, R-VA, to Thompson and Ranking Member David Scott against the nullification of Prop 12 that followed a similar October 2023 letter to Thompson and Scott signed 16 House Republicans led by front-liner Rep. Andrew Garbarino, R-NY.

To date, 230 bipartisan Members of Congress have vocalized their opposition to the nullification of state laws by Thompson and Rep. Ashley Hinson, R-IA, and Sen. Roger Marshall, R-KS, who continue to champion the assault. 171 bipartisan Members of the House sent a letter to Thompson and Scott in August of 2023 and 31 U.S. Senators sent a similar letter to Senate Agriculture Chairman Debbie Stabenow, D-MI, and John Boozman, R-AR, last August. Unfortunately, Boozman, included the nullification of state agriculture laws in his farm bill outline released earlier this year.

How 'the California Way' could drive up energy bills under a President Harris

At a recent press conference, California Gov. Gavin Newsom proclaimed what he called a "fact" -- "California has lower residential utility bills than states like Texas, states like Florida."

Ask any Californian facing sticker shock paying their summer power bills and they'll tell you a different story. Energy Information Administration figures show the average monthly price of electricity was 34.3 cents per kilowatt hour in May (second to Hawaii), compared to 14.7 cents in Texas and 13.63 cents in Florida.

These "nation leading climate policies" are an example of what Newsom calls "the California Way," and they're being picked up by Californian Kamala Harris in her presidential campaign. As documented in our new Pacific Research Institute book, the California Way encompasses bad policies on issues ranging from crime and homelessness to energy mandates and restrictions on worker freedom. Collectively. these ideas are subjecting the state's 40 million residents to higher taxes, more expensive costs, and less freedom.

Every American might eventually suffer under the California Way. As Newsom's recent political roadshow through red states illustrates, these bad policies are no longer being restricted by the Sierra Nevada mountains. They are inspiring the Biden-Harris administration -- the Los Angeles Times calls California the administration's "de-facto think tank" and state and local policymakers nationwide.

On energy, California imposes a complex array of regulations, taxes and subsidies on electricity production. These include taxpayer-funded electric car subsidies and unrealistic 100 percent renewable energy mandates. PRI's research found that Californians pay \$1,450 average annual electricity bills, with some residents paying more than \$2,000 per year. This is 56 percent more than the U.S. average, despite residents consuming 34 percent less electricity.

Worse, a recent controversial proposal would have charged people for electricity, in part, based on how much income they earned rather than how much energy they actually consumed. Despite Newsom's public relations campaign against oil com-"price gouging," Californians pay an additional \$1.41 per gallon thanks to government taxes, fees, and regulatory costs on oil production.

Don't forget the forthcoming prohibition on the sale of new gas-powered cars in the state starting in 2045. PRI's research shows the state will be conservatively 21.2 percent short of the power needed daily to charge the vehicles and meet the state's other power needs once the man-

First-of-its-kind Tool Holds Lawmakers Accountable to Farmers, Ranchers, and Rural Communities Fighting Corporate Capture and Foreign Multinational Control of U.S. Government Agencies

WASHINGTON, D.C. - Competitive Markets Action, the Institute for Legislative Analysis, and the Organization for Competitive Markets, announced the launch of the first Limited Government Agriculture Scorecard. This initiative is designed to combat cronyism in agriculture and hold lawmakers accountable to the needs of small and independent family farmers who have longbeen working to fight foreign multinational conglomerates and the Global Meat Cartel's corporate capture of U.S. agriculture.

As the agriculture industry faces increasing consolidation, it is crucial to protect those who remain—family farmers ranchers struggling against corporate-driven policies. The 2022 Agriculture Census revealed a 7% decline in the total number of farms, with more than a third of farmers now above retirement age. The urgency to stand up for independent farmers has never been greater.

One of the scorecard's key focus areas is opposition to the EATS Act, H.R. 4417/S. 2019, a bill led by U.S. Sen. Roger Marshall (R-KS), and U.S. Rep. Ashley Hinson (R-IA), which threatens to dismantle premium pork markets that have revitalized independent producers, and would nullify more than one-thousand state ag riculture laws enacted by voters and state legislators across the U.S. The China-backed legislation favors corporate agribusinesses, including Smithfield Foods, whose 2013 purchase was financed by the Chinese Communist Party, by undercutting years of investment by small farmers and American-owned companies like Hatfield Meats and Clemens Food Group with producers based in U.S. House Agriculture Committee Chairman Glenn Thompson's home

The scorecard is weighted by five metrics: support or opposition to the EATS Act, cosponsorship of the Opportunities for Fairness in Farming (OFF) Act, H.R. 1249/S. 557, an FY 24 House Agriculture Appropriations amendment addressing issues with the U.S. Dept. of Agriculture's scandal-ridden Commodity Checkoff Programs, an FY 24 House Appropriations amendment addressing Electronic Identification ear tags in cattle and bison, and actions taken on Thompson's House Farm Bill in Committee.

"For too long, mandatory checkoff programs have been a tool wielded by corporate interests to enrich themselves at the expense of small farmers and higher food prices on all Americans," said Ryan McGowan, CEO of the Institute for Legislative Analysis and creator of the scorecard, stressing the importance of transparency and reform. "The OFF Act is a critical step towards combatting corruption and bringing much needed transparency and accountability to these programs. This scorecard will shine a light on those legislators who are truly standing up for American farmers by adhering to limited government principles, and those who are content with grow-

The largest share of this support—\$150 million—will be through a set of five-year grants to Black-led justice organizations that helped to create and now sustain the momentum towards racial equality. Open Society's response reflects our conviction that real progress requires sustained support over many years and letting leaders accountable to impacted communities shape the path forward.

"It is inspiring and powerful to experience this transformational moment in the racial justice movement," said Open Society Foundations' President Patrick Gaspard. "We are honored to be able to carry on the vital work of fighting for rights, dignity, and equity for oppressed people the world over started by our founder and chair, George Soros.

"We recognize that the struggle to dismantle systemic racism is an ongoing one; it has existed from the dawn of the republic to the present day, and is embedded in every level of government and in our penal and justice systems. But the power-surge of people who have taken to the streets to demand that this nation do better—people of all ages, from all backgrounds, and in every

corner of this country—gives hope to us all."

"The success of this movement, the largest in U.S. history, will be measured over years, not weeks, and we cannot say that Black lives matter and not make a multi-year commitment to a strategy set by and centering Black leaders and organizations who changed America's sense of what is possible," said Tom Perriello, executive director of Open Society-U.S.

Recipients of this set of investments range from emerging groups to more established forces for civil rights. Among them: Black Voters Matter, Circle for Justice Innovations, Repairers of the Breach and the Equal Justice Initiative. Some are fighting for an end to policing as we know it, and others are fighting for access to the ballot. Collectively, these organizations make up a vital ecosystem of justice, one that's poised to harness the extraordinary energy of today and ensure it results in meaningful reform. "This is the time for urgent and bold action to address racial injustice in America," said Alex

Soros, deputy chair of the Open Society Foundations. "These investments will empower proven leaders in the Black community to reimagine policing, end mass incarceration, and eliminate the barriers to opportunity that have been the source of inequity for too long."

Open Society will also make a series of substantial investments, totaling \$70 million, in more immediate efforts to advance racial justice. These initiatives will in clude the following:

•Investments in a set of cities as they reimagine public safety, moving beyond the culture of criminalization and incarceration, and aiming to create safe, healthy, and racially just communities. We will fund bold and promising strategies to these ends. Through financial support, advocacy, and technical assistance, we will partner with local governments and local organizations-seeking, among other things, to strengthen local expertise in understanding and navigating municipal budgets.

•A further set of investments will go toward nurturing the civic engagement of young people, many of whom have engaged in activism for the first time in response to this extraordinary political moment in the history of our country. With summer intern-

ships cancelled in a job market ravaged by COVID-19, and high schools and colleges uncertain whether they'll be able to welcome students back to campus in the fall, Open Society's funding will create opportunities for students to enroll in internships and fellowships that focus on racial justice, democracy, organizing, and mentorship.

•Support for ongoing efforts to fight voter suppression and disinformation, and ensure safe and secure elections, in the midst of

the pandemic. In the coming weeks, Open Society will be providing further information about these and other areas of investment, including support to emergent efforts to establish truth commissions and other tools to promote racial healing—as well as funding to improve conditions particularly for Black workers and other workers of color-as labor, racial, and social justice organizations prepare for a national "Strike for Black Lives" later this

month. "Sustaining this extraordinary momentum toward centering justice for Black lives is fundamental to getting our democracy on track," said Gaspard. "We need

to combine long-term commitments to this movement with near-term opportunities, to ensure that the millions who have stepped up to take action can see enough results to stay engaged." The Open Society Foundations has been working to advance racial justice in the United States for more than two decades. Founder and Chair George Soros began his philanthropic work in the United States in the 1990s, by challenging drug laws that unfairly target African Americans. Open Society launched its Racial Justice Initiative in 2003 and has steadily grown support for those addressing systemic inequality experienced by historically marginalized communities of color. In subsequent years, the Foundations helped launch the Campaign for Black Male Achievement, investing nearly \$20 million over several years, and gave \$50 million to help the ACLU's campaign to reduce mass incarceration. date takes effect.

Then there are the green mandates putting people out of work. One recently enacted law has the state on track to ban gas-powered lawn equipment, which will be a significant cost burden on lawn care and landscaping businesses that are today a path to prosperity for many Latino entrepreneurs. Another regulation adopted by Southern California's air quality regulators would ban commercial gas ovens in kitchens by 2036, which are used to provide baked goods for restaurants and stores. This will cost about 3,200 jobs once fully implemented.

Some may argue that these wild policies won't catch on nationally. Think again. The recent controversy over federal bureaucrats reportedly considering a ban on gas stoves, emulating an idea that first caught steam in Sacramento, shows the California Way is spreading nationwide. With Californian Harris now topping the presidential ticket, the California Way previews a future Harris administration's policy agenda, on green policy and so much more.

ing the size and scope of government to benefit select corporations".

"For decades we've been shut out of policy making in Washington, D.C., because of the likes of the so-called National Pork Producers Council, National Cat-Beef Association, tlemen's American Farm Bureau, and others who have hijacked and coopted the voices of the American family farmers they have falsely claimed to represent," said Taylor Haynes, President of the Organization for Competitive Markets and Founder of the Wyoming Independent Cattlemen's Association. "If we don't act now, we will see even more family farms driven out of business by cronyistic policies designed to benefit foreigncontrolled entities Smithfield. We're proud to launch our new scorecard that will serve as a vital tool to hold federal lawmakers in the Swamp accountable for their actions, and protect our American family farmers from predatory practices, the Global Meat Cartel, foreign multinational conglomerates and

special interest groups like the so-called National Cattlemen's Beef Association, that have hijacked and coopted the voices of the very producers they are putting out of busi-

"The American family farmer can't afford another Farm Bill like the one Glenn Thompson passed through the House Committee in May, and we are not going to take it anymore," said Mike Schultz, Vice-President of the Organization for Competitive Markets and Founder of the Kansas Cattlemen's Association. "Corporate capture of our own USDA, FDA, and other agencies has enabled foreign multinational conglomerates like Smithfield and JBS to wipe out farmers all across America and we're now one catastrophe away from seeing a run on the food banks in our nation. Until we get open and competitive competition with full market transparency, we will see further concentration and consolidation."

"It's time for Congress to pay attention and listen the voices of the American farmers who put food on the table and stop listening to those who continue to use USDA checkoff funds to illegally lobby Congress and the Administration in support of policies that give the farm away to China and other foreign enemies who seek to destroy our country," said Jonathan Buttram, President of the Alabama Contract Poultry Growers Association and Treasurer at the Organization for Competitive Markets. "The swamp rats in D.C. have created a serious national security threat in American food production and it's high-time the voters in their states and districts were informed."

Additionally, the scorecard evaluates support for the OFF Act, a bipartisan effort led by U.S Reps. Nancy Mace (R-SC) and Dina Titus (D-NV), along with U.S. Sens. Mike
