MEMPHIS, Tenn. – The University of Memphis and head football coach Ryan Silverfield have agreed to a new, five-year contract through the 2028 season. Silverfield is entering his

In 2023, Silverfield guided the Tigers to a 10-3 season, including a win in the AutoZone Liberty Bowl, 36-26, over Iowa State. The 10-win season was

just the fifth in program history.

"We are extremely excited to make this commitment to Coach Silverfield to keep him leading our football program into the future," University of Memphis Vice President and Director of Intercollegiate Athletics Laird Veatch said. "Coach Silverfield guided the team to one of the best seasons in program history in 2023 and we believe he's laid the foundation to help Memphis ascend even higher in the expanded College Football Playoff era."

Silverfield is the only head coach in program history with four bowl titles in his first four seasons. His four bowl titles are also the most for any head coach in school history.

His 31 victories are the secondmost in program history for a head coach in his first four seasons, while those wins rank in a tie for fourth nationally among head coaches hired in 2020.

For his efforts in 2023, Silverfield was named the Tennessee Sports Writers Association (TSWA) Coach of the Year, becoming the first Memphis head coach to earn the honor twice

hird Circuit denies rehearing in SAF PA gun rights victory; Second Amendment affirmed

April 1, 2024 - The Third U.S. Circuit Court of Appeals has denied a petition for a rehearing in the Second Amendment Foundation's victory in a case challenging Pennsylvania statutes that prohibit law-abiding young adults from carrying firearms for self-defense and prevents them from acquiring a state license to carry (LTCF) because of their age. The case is known as Lara v. Evanchick.

The petition for an en banc rehearing had been filed by attorrepresenting neys Commissioner of the Pennsylvania State Police. SAF is joined in the case by the Firearms Policy Coalition and three private citizens, including Madison M. Lara, for whom the case is named. They are represented by attorneys David H. Thompson,

Ohlendorf at Cooper & Kirk, Washington, D.C.

Writing for the majority, Circui Judge Kent A. Jordan explained, "The petition for rehearing filed by appellant in the above-entitled case having been submitted to the judges who participated in the decision of this Court and to all the other available circuit Peter A. Patterson and John D. judges of the circuit in regular
