TSU holds off Arkansas Pine Bluff to claim win in Southern Heritage Classic

MEMPHIS- The 34th annual Southern Heritage Classic was held at Simmons Bank Liberty Stadium in Memphis on September 9. This year's edition featured a first-time participant in Arkansas Pine Bluff taking on the TSU Tigers. The Tigers prevailed in a thrilling 24-14 victory. It was the first win in 3 tries for Tigers' coach Eddie George at the Classic.

The Tigers jumped out to a 7-0 1st quarter lead on a Jordan Gant 4-yard touchdown run. Pine Bluff could not get anything going on offense in the 1st. TSU added to their lead late in the 1st on a 1-yard touchdown run from Demeatric Crenshaw.

Defenses took over in the 3rd quarter. The only scoring was a 23-yard field goal by the Tigers with 35 seconds left. That made the score 17-0 going into the 4th quarter.

The Pine Bluff Golden Lions did not quit. They came roaring back with a Johness Davis 4yard touchdown run early in the 4th to cut the lead to 10 points. The Lions struck again on another touchdown, this one from Kevin English to make the score 17-14.

Pine Bluff got the ball back late in the game and was driving to tie or take the lead. They had to settle for a field goal attempt with 37 seconds left. In what was the play of the game, the attempt was blocked. TSU's James Green returned the blocked field goal 92 yards for a touchdown that sealed the win for the Tigers. It was one of the most dramatic endings to a game in the history of the Classic.

The win improved Tennessee State's record to 1-1 on the season while the Golden Lions fell



WASHINGTON, D.C. — NSSF, The Firearm Industry Trade Association, is warning New Mexico Gov. Michelle Lujan Grisham to not attempt to enforce her Public Health Order requiring the state's Regulation and Licensing Division to conduct monthly inspections of licensed firearm retailers to ensure compliance with all sales and storage laws, in addition to unconstitutionally banning the Second Amendment right to bear arms in public spaces.

'There is no other way to say it other than the entire order is blatantly unlawful," said Lawrence G. Keane, NSSF Senior Vice President and General Counsel. "New Mexico's governor does not have the authority to suspend rights protected by the Constitution for a falsely-labeled public

There is no New Mexico statute, nor any New Mexico regulations, on compliance or storage requirements. Firearm retailers in New Mexico are heavily regulated by

Firearms and Explosives (ATF) and are subject to federal laws and regulations governing the lawful and constitutionally-pro-
