## Pres. Donald J. Trump to address NRA members at 153rd Annual Meeting set for May 18 in Dallas

## SAF files memo in Jr. Sports case in lawsuit accusing California of not cooperating in business codes

Attorneys representing the Second Amendment Foundation and its partners in a case known as Junior Sports Magazines v. Bonta have filed a memorandum of points and authorities supporting their earlier motion to enforce a court mandate and issue a preliminary injunction. The memorandum was filed in U.S. District Court for the Central District of California. SAF and its partners sued California, challenging the state's Business and Professions Code §

*"The state is clearly dragging its feet in this case, making every effort to stall the process," said SAF Executive Director Adam Kraut. "The state has been very uncooperative since the Ninth Circuit Court ruled against the state last September and issued its mandate in February. This legal gamesmanship needs to stop."*

22949.80, which prohibits advertising of any "firearm-related product in a manner that is de-

signed, intended, or reasonably appears to be attractive to minors." This was an important First Amendment issue, and the lawsuit resulted in a victory for the plaintiffs. Junior Sports Magazine included advertising from firearms companies, which the state code prohibited. A three-judge panel of the Ninth Circuit Court of Appeals held the statute to be likely unconstitutional under the First Amendment.
