Cong. Mark Green's letter used as reason for 'as long as evil persists...for good people to defend themselves'

"As long as evil persists, there will always be a need for good people to defend themselves and their loved ones."

That noteworthy quote is taken from a letter sent on behalf of eighty-eight members of Congress to Commerce Department Secretary Gina Raimondo and Commerce Under Secretary Alan F. Estevez regarding the Department's decision to "pause" the issuance of new export licenses involving "certain firearms, related components and ammunition."

The letter, originating from the office of Congressman Mark Green (7th District, TN) expresses concern over the "Broad mandates, no comment period, few details, and the massive caveat that BIS retains the authority to do virtually anything else it deems appropriate."

Actions, the letter points out,

"not characteristics of a democratic republic."

The letter continues to call to task the "inherent hypocrisy" of calling the "pause" then exempting Israel and Ukraine from the restrictions. "If," it says, "that it is true that guns are the cause of violence, as the President likes to say, then BIS would have included Ukraine and Israel in this pause."

"BIS did not," it concludes,

"proving the necessity of an armed citizenry to deter and repel tyranny."

In fact, Green wrote, "The surprise attacks against Israel should dispel any notion that BIS can justify or assess who needs firearms for defense."

"The need for a Second Amendment was not limited to the American Revolution," it continued, "nor the American Republic. Every person has a right to self-defense. Not only does BIS's pause on firearms export licenses leave people more vulnerable, but it will also push buyers to look elsewhere to meet consumer demand."

That's not exactly the job of the Commerce Department. Nor is it the job of the Commerce Department to take actions that will potentially affect thousands of Americans whose jobs are tied to the very business the BIS division has "paused."

Those, however, are only part of the reasons the eighty-eight members of Congress are perturbed. •Did Commerce/BIS interface with "advocacy organizations" prior to the decision?

•Have there been any meetings with stakeholders since the

•At the end of 90 days, will there be advance notice to temporary or permanent changes? And will those chances be submitted to Congress for review?

•Did they "coordinate or collaborate" with, or involve in any way, the White House Office of Gun Violence Prevention on the decision? If so, they wrote "please describe in detail."

•Please describe "in detail" why exports to Ukraine and Israel are necessary, while exports to Taiwan are not.

The letter then "respectfully" asked for answers to the questions of Congress by November 13, 2021. That was...yesterday. And as of 5p.m. Eastern time on Monday, November 13, 2023, there was no response from the Commerce Department.

If/when Secretary Raimondo responds to the request for information, we'll let you know.

In the meantime, we'll keep you posted.
