JUNCTION CITY, Kan. -Eight of the country's best college anglers will launch on Milford Lake from Junction City, Kan., Sept. 29-Oct. 2 during the Bassmaster College Classic Bracket presented by Lew's, fishing for a berth in the 2024 Academy Sports + Outdoors Bassmaster Classic presented by Toyota.

The 2023 Bassmaster College Team of the Year — Easton Fothergill and Nick Dumke from the University of Montevallo automatically punched their ticket to the College Classic Bracket to compete alongside the Top 3 teams from last week's Strike King Bassmaster College Series National Championship presented by Bass Pro Shops in this individual, elimination-style tournament.

Joining Fothergill and Dumke, who finished fifth at the National Championship, will be national champions Hayden Marbut and Tucker Smith from Auburn University, Levi Mullins and Matthew Cummings from Bethel University and a second Montevallo team, Brody Robison and Jack Alexander.

The final day of competition will be streamed on Bassmaster.com.

In addition to a spot in the Bassmaster Classic, the College Classic Bracket champion will also earn paid entry into the 2024 St. Croix Bassmaster Opens and the use of a Toyota Tundra and a Nitro Boat.

# Fish on the move as sea water warms; Two new state king mackerel records made where kings are rarely caught

On the last weekend in July, Joe Vricella and his dad Dominic brought in a 67.45 pound king from 5 miles off the New Jersey beaches, a fish that blew away the old record by more than 10 pounds. (That fish would have won most Florida, Alabama and Louisiana tournaments as wella true monster!)

And at almost the same time, the Delaware Department of Natural Resources and Environmental Control announced that a Millsboro angler Jeff McCoy had caught a 52-pound, 11.2-ounce king mackerel along Fenwick

His king mackerel, with a 56inch fork length and 24-inch girth, bested the previous 31-year Delaware record by 4 pounds, 2.2 ounces.

Blitzes of king mackerel have showed up off Cape Cod in recent years, as well.

Kings stay out of water colder than 68 degrees when possible. Last year NJ beaches had an all-

time water temp record set, 84.2 F. It's around 79 right now.

While kings are unlikely to become abundant enough in this area to make them a target species, their presence shows just how saltwater fish can take advantage of suitable habitat when it becomes available to expand their territory.

Something similar has happened with snook in inshore waters around Florida over the past 20 years. The species is now found regularly as far north as the Suwannee River on the state's west coast, at least 100 miles farther north than the "Snook Line" at Tarpon Springs had been forever previous to the 1980's.

Florida state biologists say breeding populations are now present around Homosassa, Crystal River and Cedar Key and the fish use the Suwannee and other coastal rivers as winter refuge during the occasional freezes. Some of the fish have gone 100 miles up the Suwannee in winter, though most stay in the lower brackish areas in deep holes. (There have long been a

## 2019 Mississippi Bonnet Carré Spillway disaster recovery program for assistance is now open

Biloxi, MS - The 2019 Mississippi Bonnet Carré Spillway Fisheries Disaster Recovery Program financial assistance applications for commercial fisheries and charter boat participants is now open on the Mississippi Department of Marine Resources (MDMR) website dmr.ms.gov/2019bcrelief/.

Applicants must be a Mississippi resident 18 years or older and have possessed a valid Mississippi resident commercial fishing or dealer 2019 calendar year lithrough trip tickets during the following five historical license years (May 1-April 30) 2014-2018. To qualify as a dealer, applicants must have been in possession of an active dealer license in 2019, have purchased seafood from an active Mississippi commercial fisherman between 2014 and 2018 and records of these transactions must be present in the MDMR trip ticket database. Eligible Mississippi resident charter boat captains must be 18 years or older and possessed a valid Mississippi resident charter boat license for the 2019 calendar year and at least one of the previous five years (2014-2018).

If applying as a business, it must be domiciled in Mississippi and registered with the Mississippi Office of the Secretary of State. Participants must not be debarred, not on the government "do not pay list" and in good standing with the federal and state government.

Applications will be open for 30 days and will close Thursday, September 7, 2023, at 11:59 p.m.

No late applications will be considered and there will be no appeals if the deadline is missed. Funding allocation has been structured so that only applications submitted by the deadline will be considered. Payout will be based on all individual fishermen values across all fisheries and funds distributed proportionally based on overall value of all fisheries and participation in all fisheries as determined by the MDMR, without the need for any supplemental documentation from applicants.

The following information will be needed for the application procense with MDMR documented cess: contact information, valid landings, verified by MDMR email address, all applicable 2019 calendar year fishing license numbers, date of birth and social security number or employer ID tax number. A W-9 form, incorporated into the application, will also be required for payment, and retained by MDMR.
