# Ninth Circuit denies en banc hearing in **Junior Sports case**

#### **From The Shooting Wire**

BELLEVUE, WA - The Second Amendment Foundation is cheering the decision by a 9th Circuit Court panel to deny the State of California an en banc hearing in a case known as Junior Sports Magazines, Inc. v. Bonta, in which the state tried to prohibit firearm advertising which it claims, "reasonably appears to be attractive to minors.'

SAF is joined in the case by Junior Sports Magazines, the California Youth Shooting Sports Association, Redlands California Youth Clay Shooting Sports, California Rifle & Pistol Association, CRPA Foundation, Gun Owners of California and Raymond Brown, a private citizen. "It seems like forever since the 9th Circuit has refused to hear a gun case en banc," said SAF founder and Executive Vice President Alan M. Gottlieb. "Hopefully, this is a new trend."

SAF attorney Donald Kilmer noted, "This means that our win before the three-judge panel will become the case law on this issue in the Ninth Circuit. It means the trial court's denial of a preliminary injunction remains reversed and that court will be required to enter a preliminary injunction, preventing enforcement of this law while the case proceeds to final judgment."

SAF Executive Director Adam Kraut said the court's decision is a victory for the First Amendment as well as the Second. "The state was determined to regulate the First Amendment as well as the Second," Kraut stated, "and we prevented California from continuing to enact unconstitutional laws. We're pleased the 9th Circuit has decided to leave the panel's decision undisturbed."

This is a ground-breaking First Amendment case, which defends the right of Junior Sports Magazine and other periodicals to publish Second Amendment-related material in California.

# NFL announces finalists for the Sixth Annual **Big Data Bowl Powered by AWS; Breaks the** record for the sports analytics competition

NEW YORK - Feb. 20, 2024 The National Football League announced the finalists for the sixth annual Big Data Bowl powered by Amazon Web Services (AWS). The yearly sports analytics competition hosted by the NFL Football Operations Data and Analytics team allows members of the data analytics community to contribute to the NFL's expanding world of advanced statistics and new metrics. This year's Big Data Bowl participants are eligible for \$100,000 in prize money, with each finalist receiving \$12,500 and runners-up receiving \$5,000. The 2024 Big Data Bowl theme is focused on analyzing tackling performance across the NFL. Finalists in the competition were given access to the NFL's Next Gen Stats (NGS) from Week 1 through Week 9 of the 2022 NFL season, analyzing metrics such as location, speed and acceleration of all 22 players on the field for any given play. This year's competitors submitted over 300 submissions, a record for the Big Data Bowl.

This year's competition will conclude with an in-person event at the 2024 NFL Scouting Combine presented by NOBULL in Indianapolis on Wednesday, Feb. 28, with the five finalists competing for an additional \$12,500 in prize money. The keynote speaker of the event will be Mike Fitzgerald, vice president of research and development and assistant general manager with the Arizona Diamondbacks, who will discuss how to implement modern data science and analytical tools in professional sports organizations.

Since 2017, the NFL has been proud to utilize AWS's machine learning and data analytics services to develop new insights via the NGS platform that continually reshape the league and change how fans experience the game. In past years, the Big Data Bowl has generated innovative metrics in the play of offensive and defensive linemen, special teams strategy and pass coverage.

The Big Data Bowl has continued to be a strong pipeline for data scientists looking to begin a career in the sports analytics industry. More than 50 Big Data Bowl contestants have been hired in the sports data and analytics field, with over 30 of those participants being hired by NFL clubs and player-tracking vendors.

For the sixth straight year, the Big Data Bowl featured a mentorship program. This partnership led to outstanding results, with two previous mentees being named 2024 honorable mentions.

For the second year, a new coaching-centric track was implemented, which encouraged coaches to partner with data scientists on a submission. Three of our finalists are women in this year's contest which is the highest on record.

The Big Data Bowl is hosted by Kaggle, the world's largest community of machine learning practitioners, learners and researchers.

MEMPHIS, Tenn. - The University of Memphis women's basketball team continued its hot streak on Tuesday night, defeating Rice 79-74 in overtime to give head coach Alex Simmons her 100th career win.

With the victory, Memphis improves to 10-15 overall and 6-8 in American Athletic Conference play.

Following a back-and-forth

A 12-2 run in the fourth quarter by Rice gave them the lead and Memphis faced a deficit for the first time since the 5:18 mark in the opening quarter.

The Tigers and Owls traded baskets throughout the remainder of duo of Riddick and Smith came storming back on the offensive end. Following a Riddick free throw, Smith nailed a threepointer from the corner to give the Tigers a two-point advantage. On the next trip down the floor, Riddick completed an and-one for the two-possession lead. Rice ended up going 3-for-4 from the charity stripe late in the game while Memphis got two makes from Smith to ice the game and give the Tigers the 79-74 win. Alasia Smith led the team with her eighth double-double of the season of 18 points and 14 rebounds while Hannah Riddick came off the bench for an 18point performance, shooting 7for-8 from the field. Madison Griggs and Shelbee Brown also chipped in double-digit scoring with 12 and 11 points, respectively, while Griggs dished out a

career-high seven assists. Memphis is back on the road this weekend when it heads to New Orleans to face-off with Tulane. Tip-off on Saturday is scheduled for 2 p.m. with coverage available on ESPN+.

With the upcoming 2024 International Game in South America, the NFL will have played a game (preseason or regular season) in five of the seven continents

around the world.
