point mark 18 times and reaching 30 points on four occasions.

Quinerly is on the all-conference third team at the end of the year after being picked to the first team in the preseason.

As the floor general for the Tigers, he has started 30-of-31 games and posted career-high numbers in almost every category, averaging 13.7 points, 5.0 assists, 3.2 rebounds and 1.3 steals per game in a team-high 32.6 minutes each time out.

The Hackensack, New Jersey product is fourth in the league in assists per game, total assists (154) and assists/turnover ratio (2.14).

Quinerly is shooting 41.4 percent overall (137-331) from the field and has hit a career-high 57 three-pointers. The fifth-year senior is second on the team at the free throw line, connecting on 94-of-118 attempts for a 79.7percent clip.

He is a two-time AAC Weekly Honor Roll recipient and was named the league's player of the week on January 15 after posted 24.0 points and 7.5 assists per game in wins over UTSA and Wichita State. That honor came on the heels of hitting back-togame game-winning triples in the final four seconds at Tulsa (Jan. 4) and against SMU (Jan. 7) in the first week of conference ac-

Quinerly has scored double figures in 22 games, including five games of 20 or more points, and dished five or more assists 17 times.

The Tigers (22-9, 11-57 AAC) are seeded fifth in the 2024 American Athletic Conference Men's Basketball Championship and will take the court at Dickies Arena in Fort Worth, Texas, Thursday at 1:30 p.m. CT on ESPNU.

Memphis will face the winner of Wednesday's first-round matchup between No. 12 Wichita State and No. 13 Rice. With a win, the Tigers would play No. 4 UAB in the quarterfinals Friday at 2 p.m. on ESPN2. The semifinals would be Saturday at 2 p.m. on ESPN2 and the championship game is Sunday at 2:15 p.m. on ESPN.

B.A.S.S. youth events are slated for Chickamauga this summer for fun

DAYTON, Tenn. — The eyes of the fishing world are on young anglers after 19-year-old Trey McKinney made history last week, becoming the youngest pro to win a Bassmaster Elite Series event. And this summer, hundreds of the top young anglers from across the country will descend on eastern Tennessee, with the next big star quite possibly among them.

B.A.S.S. officials announced today that the Bassmaster Junior National Championship will be held July 26-27 on Chickamauga Lake, followed by the Strike King Bassmaster High School National Championship on Aug. 1-3. The City of Dayton will host both events, with daily takeoffs and weigh-ins held at Dayton Boat Dock.

The Junior Series event will feature anglers from grades second through sixth, while the High School Series event will have a field comprised of seventh- to 12th-graders. With the High School and Junior Series kicking off this past February, young anglers are busy qualifying now through regular-season events at both levels.

"If people weren't paying attention to youth anglers before, they certainly are now," said Glenn Cale, B.A.S.S. Nation tournament manager for the College, High School and Junior Series. "Not only are these guys fiercely competitive amongst themselves, but some of them will likely be making waves on the top-level circuits very soon.

Chickamauga has been the backdrop for many major B.A.S.S. events, including one of the wildest Bassmaster Elite Series tournaments in recent memory in 2022. Oklahoma pro Jason Christie won that event with a four-day total of 73 pounds, 7 ounces despite weather that ranged from 70 degrees with bright sunshine to high 30s with snow flurries.

The young anglers should arrive for the two summertime championships to find warmer tem-

mauga shines brightest.

National Football League announces 34 compensatory 2024 draft choices to 14

NEW YORK - March 8, 2024 — A total of 34 compensatory draft selections in the 2024 NFL Draft have been awarded to 14 teams, the NFL announced.

Under the rules for compensatory draft selections, a team losing more or better compensatory free agents ("CFA") than it acquires in the previous year is eligible to receive compensatory draft picks.

The compensatory picks will be positioned within the third through seventh rounds based on the value of the compensatory free agents lost.

Compensatory free agents are determined by a formula based on salary, playing time and postseason honors. The formula was developed by the NFL Management Council. Not every free agent lost or signed by a club is covered by this formula. Clubs



that suffer a net loss of CFAs during the prior free agent signing period are eligible to receive a corresponding number of compensatory selections.

In addition, a club that lost the same number of CFAs that it gained (no net loss), may be eligible to receive a selection at the end of round seven based on the value of the CFAs lost versus the value of the CFAs gained. No club may receive more than four compensatory picks in any one year. If a club qualifies for more than four compensatory picks after offsetting each CFA lost by each CFA gained of an equal or

maining selections will be awarded to the club. The Collective Bargaining

Agreement limits the number of compensatory selections to the number of clubs then in the clubs, the Dallas Cowboys, Green Bay Packers, and Jacksonville Jaguars qualified for a compensatory selection under the net loss formula but will not receive that pick because the final numerical value of the CFA who was lost ranked 33rd or lower among the final numerical values of all compensatory selections. Each of those clubs will receive compensatory selections for other CFAs lost whose final numerical value ranked within the top 32.

ment remotely connected to limiting the number of firearms a person can purchase. This limitation is blatantly unconstitutional, and if this ruling is appealed by the State of California, we intend to defend the lower court's correct decision."

In his 24-page decision, Judge Hayes wrote, "Defendants have not met their burden of producing a "well-established and representative historical analogue" to the OGM law. The Court therefore concludes that Plaintiffs are entitled to summary judgment as to the constitutionality of the OGM law under the Second Amendment."
