"We have school choice in Texas. If you don't like your public school, you can go to private school or homeschool."

That's a familiar refrain from opponents of creating school choice programs, like vouchers or education savings accounts.

They are, of course, technically correct because those are legal

alternatives to sending kids to public school. But it's also disingenuous. They know those options have incredibly high barriers for most parents, especially middle- and working-class single parents.

If someone doesn't have reasonable access to something, can it really be considered a choice? I suppose I legally have the right to drive a Rolls-Royce or Ferrari, but I can assure you that neither of those cars are in any reasonable way a "choice" for me. Further, the purpose of choice is not just to have options for the sake of having options. Increasing choices puts upward pressure on the market leader to make services better and more affordable. Does anybody honestly believe public school officials feel any upward pressure to make education better right now, even as half of Texas students can't read or do math on grade-level? And this gets to the real point of the current debate over ESAs. The one thing both sides agree on is that if given the option -areal option - millions of parents would choose an education for their kid other than what their local public school is offering. If the education establishment cared more about why that is and addressed the concerns of parents, we wouldn't need to change the law to give parents a real choice.

From our Archives: The History of Black History

Editor's Note: This article was written by the late Vernon E. Ash, columnist for The Mid-South Tribune, The article was first published the 1996 Black History Month Special Edition.

"So that the contributions of African Americans would be properly represented and observed, the first observance of Negro History Week was spearheaded in 1926 by the "Father of Black History," Dr. Carter G. Woodson.

Dr. Woodson is the author of the popular book, "The Mis-Education of the Negro," published in 1933 and still viewed today as an important source and guidebook on the behavior and mental condition of African Americans. He was born in 1875 and died in 1950.

Other African Americans who supported Dr. Woodson's idea collaborated with the black history scholar to choose the second week of February as the week to observe the special Negro History Week. This month and week were selected because it is the week of the birthdays of Frederick Douglass and Abraham Lincoln, both highly respected at the time.

In 1915, Dr. Woodson founded the Association for the Study of Negro Life and History (ASNLH) and began publishing The Journal of Negro History a year later. In the October 1927 edition of the Journal, Dr. Woodson wrote passionately about the significance of observing Negro History Week.

"The celebration tends not to promote propaganda, but to counteract it by popularizing the truth. It is not interested so much in Negro History as it is in history influenced by the Negro; for what the world needs is not a history of selected races or nations but the history of the world void

of national bias, race hate, and religious prejudice," Dr. Woodson wrote. "There has been, therefore, no tendency to eulogize the Negro, nor to abuse his enemies. The aim has been to emphasize important facts in the belief that facts properly set forth will speak for themselves."

With the strong support of educators, ministers and community leaders around the nation, the first Negro History Week proved to be a tremendous success. Each group and institution took responsibility to initiate its own programs and forums to fit their particular needs in their local communities.

The popular use of the word "Negro" was replaced in the

1960s with "Black" and "Afro-American". This new trend also forced a change in the name of the ASNLH. During its 1972 convention, delegates changed its name to the Association for the Study of Afro-American Life and History (ASALH). Negro History Week was then changed to Black History Week.

During the nation's Bicentennial celebration in 1976, the ASALH joined the focus on American history and decided to expand the observance of Black History Week to include the entire month of February. This was done to afford more time for activities focusing on the broad contributions of African Americans to the rich history of America and the world.

Black History Month has survived several decades and continues to grow throughout the U.S. with a variety of activities and commemorations that place the great contributions of Africans (being the original human creation) and African Americans

President Trump's Executive Order: Protecting Children from Chemical & Surgical Mutilation

January 28, 2025

By the authority vested in me as President by the Constitution and the laws of the United States of America, it is hereby ordered: Section 1. Policy and Purpose. Across the country today, medical professionals are maiming and sterilizing a growing number of impressionable children under the radical and false claim that adults can change a child's sex through a series of irreversible medical interventions. This dangerous trend will be a stain on our Nation's history, and it must end.

Countless children soon regret that they have been mutilated and begin to grasp the horrifying tragedy that they will never be able to conceive children of their own or nurture their children through breastfeeding. Moreover, these vulnerable youths' medical bills may rise throughout their lifetimes, as they are often trapped with lifelong medical complications, a losing war with their own bodies, and, tragically, sterilization.

Accordingly, it is the policy of the United States that it will not fund, sponsor, promote, assist, or support the so-called "transition" of a child from one sex to another, and it will rigorously enforce all laws that prohibit or limit these destructive and life-altering procedures.

Sec. 2. Definitions. For the purposes of this order:

(a) The term "child" or "children" means an individual or individuals under 19 years of age.

(b) The term "pediatric" means relating to the medical care of a child.

(c) The phrase "chemical and surgical mutilation" means the use of puberty blockers, including GnRH agonists and other interventions, to delay the onset or progression of normally timed puberty in an individual who does not identify as his or her sex; the use of sex hormones, such as androgen blockers, estrogen, progesterone, or testosterone, to align an individual's physical appearance with an identity that differs from his or her sex; and surgical procedures that attempt to transform an individual's physical appearance to align with an identity that differs from his or her sex or that attempt to alter or remove an individual's sexual organs to minimize or destroy their natural biological functions. This phrase sometimes is referred to as "gender affirming care."

Sec. 3. Ending Reliance on Junk Science. (a) The blatant harm done to children by chemical and surgical mutilation cloaks itself in medical necessity, spurred by guidance from the World Professional Association for Transgender Health (WPATH), which lacks scientific integrity. In light of the scientific concerns with the WPATH guidance:

i) agencies shall rescind or amend all policies that rely on WPATH guidance, including WPATH's "Standards of Care Version 8"; and

(ii) within 90 days of the date of this order, the Secretary of Health and Human Services (HHS) shall publish a review of the existing literature on best practices for promoting the health of children who assert gender dysphoria, rapid-onset gender dysphoria, or other identity-based confusion.

(b) The Secretary of HHS, as appropriate and consistent with applicable law, shall use all available methods to increase the quality of data to guide practices for improving the health of minors with gender dysphoria, rapid-onset gender dysphoria, or other identity-based confusion, or who otherwise seek chemical or surgical mutilation.

Sec. 4. Defunding Chemical and Surgical Mutilation. The head of each executive department or agency (agency) that provides research or education grants to medical institutions, including medical schools and hospitals, shall, consistent with applicable law and in coordination with the Director of the Office of Management and Budget, immediately take appropriate steps to ensure that institutions receiving Federal research or education grants end the chemical and surgical mutilation of children.

Sec. 5. Additional Directives to the Secretary of HHS. (a) The Secretary of HHS shall, consistent with applicable law, take all appropriate actions to end the chemical and surgical mutilation of children, including regulatory and sub-regulatory actions, which may involve the following laws, programs, issues, or documents:

- i) Medicare or Medicaid conditions of participation or conditions for coverage;
- (ii) clinical-abuse or inappropriate-use assessments relevant to State Medicaid programs;
- (iii) mandatory drug use reviews;
- (iv) section 1557 of the Patient Protection and Affordable Care Act;
- (v) quality, safety, and oversight memoranda;
- (vi) essential health benefits requirements; and

(vii) the Eleventh Revision of the International Classification of Diseases and other federally funded manuals, including the Diagnostic and Statistical Manual of Mental Disorders, Fifth Edition.

(b) The Secretary of HHS shall promptly withdraw HHS's March 2, 2022, guidance document titled "HHS Notice and Guidance on Gender Affirming Care,

Civil Rights and Patient Privacy" and, in consultation with the Attorney General, issue new guidance protecting whistleblowers who take action related to ensuring compliance with this order.

Sec. 6. TRICARE. The Department of Defense provides health insurance, through TRICARE, to nearly 2 million individuals under the age of 18. As appropriate and consistent with applicable law, the Secretary of Defense shall commence a rulemaking or sub-regulatory action to exclude chemical and surgical mutilation of children from TRICARE coverage and amend the TRICARE provider handbook to exclude chemical and surgical mutilation of children.

Sec. 7. Requirements for Insurance Carriers. The Director of the Office of Personnel Management, as appropriate and consistent with applicable law, shall: (a) include provisions in the Federal Employee Health Benefits (FEHB) and Postal Service Health Benefits (PSHB) programs call letter for the 2026 Plan Year specifying that eligible carriers, including the Foreign Service Benefit Plan, will exclude coverage for pediatric transgender surgeries or hormone treatments; and

(b) negotiate to obtain appropriate corresponding reductions in FEHB and PSHB premiums.

Sec. 8. Directives to the Department of Justice. The Attorney General shall:

(a) review Department of Justice enforcement of section 116 of title 18, United States Code, and prioritize enforcement of protections against female genital mutilation;

(b) convene States' Attorneys General and other law enforcement officers to coordinate the enforcement of laws against female genital mutilation across all American States and Territories;

(c) prioritize investigations and take appropriate action to end deception of consumers, fraud, and violations of the Food, Drug, and Cosmetic Act by any entity that may be misleading the public about long-term side effects of chemical and surgical mutilation;

(d) in consultation with the Congress, work to draft, propose, and promote legislation to enact a private right of action for children and the parents of children whose healthy body parts have been damaged by medical professionals practicing chemical and surgical mutilation, which should include a lengthy statute of limitations; and

(e) prioritize investigations and take appropriate action to end child-abusive practices by so-called sanctuary States that facilitate stripping custody from parents who support the healthy development of their own children, including by considering the application of the Parental Kidnapping Prevention Act and recognized constitutional rights.

Sec. 9. Enforcing Adequate Progress. Within 60 days of the date of this order, the heads of agencies with responsibilities under this order shall submit a single, combined report to the Assistant to the President for Domestic Policy, detailing progress in implementing this order and a timeline for future action. The Assistant to the President for Domestic Policy convene the heads of agencies with responsibilities under this order (or their designees) to coordinate and prepare for this submission.

Sec. 10. Severability. If any provision of this order, or the application of any provision to any person or circumstances, is held to be invalid, the remainder of this order and the application of any of its other provisions to any other persons or circumstances shall not be affected thereby.

Sec. 11. General Provisions. (a) Nothing in this order shall be construed to impair or otherwise affect:

- (i) the authority granted by law to an executive department or agency, or the head thereof; or
- (ii) the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- (b) This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

(c) This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person.

BACKGROUND:

In 1866, Congress created six all-Black peacetime regiments to protect settlers, build roads and other infrastructure, and guard U.S. mail in the Western frontier. Buffalo Soldiers would go on to serve in military operations including the Spanish American War, World War I, World War II, and the Korean War.

The Buffalo soldiers' impact reached across the country as the U.S. forged its national parks. They not only served in combat and as protectors around the country, but they also broke down barriers and demanded civil rights. The all-Black regiments served during a time of segregation in the U.S. military, and faced bigotry and discrimination, often from those they were assigned to protect.

Congressional Marilyn Strickland (WA-10) serves on the House Armed Services Committee and the House Transportation and Infrastructure Committee. She is Whip of the New Democrat Coalition, Secretary of the Congressional Black Caucus, the first African-American to represent Washington State and the Pacific Northwest, and one of the first Korean-American women elected to Congress.





Supreme Court Justice Clarence Thomas

I was editor-in-chief of another newspaper when Clarence Thomas was going through his "High Tech Lynching" congressional hearings. Like most of America, we were watching the hearings but in the press room. At the time I received a call from what would now be called a legacy newspaper. The reporter asked me what I thought about Clarence Thomas. I said something like, "Let's give him a chance. Let's see what he has to say." Little did I realize that I would receive a call about a day or two later from the White House in which the person began, "The President read what you said...Would it be okay, if

we sent you some files and background material on Clarence Thomas?"

"I don't mind," I said. Of course, in these pre-email days, the package was FedExed. In this thick package, I read thoroughly speeches by Clarence Thomas and other background material. This just reinforced where I was leaning long before that package came, originating from that White House call. What Thomas was going through was brutal and it angered me that the socalled Black establishmentarians were taking him through this because he was a Black who dared to be Republican! How ironic and how sad, I remember discussing with one of our senior political columnists who happened to have been a Black man who served in World War II and a

staunch Democrat who found himself backing Thomas, too. Another political columnist who was White and Harvard-educated was against Thomas. These two men were my father's age, so I had respect for them both. Sadly, both are now deceased.

Of course, in the history of my career, I have and had interviewed such Civil Rights leaders as Jesse Jackson, Louis Farrakhan, T.O. Jones (who led the Sanitation Strike which brought Dr. Martin Luther King, Jr. to Memphis) as he practically lay on his death bed, and other known and unknown Civil Rights leaders and activists. Yes, as editor I went against those in the NAACP and others who

"Reaching Black consumers may not be a challenge—but connecting with us can be. Black consumers are leaning into platforms that emphasize conversation and create a sense of connection," says Charlene Polite Corley, Vice President of Diverse Insights & Partnerships. Black audiences continue to be power TV viewers, spending 46 hours and 13 minutes per week watching TV, compared to almost 35 hours for the total U.S. population. 46% of that time is spent on streaming, which is gaining share year-over-year with Black adults. YouTube is the top platform-where Black audiences spend 13% of their total TV time, compared to 10% for all U.S. viewers. In fact, YouTube reaches 63% of Black adults and 44% report that they have purchased products based on You-Tube content. The preference for YouTube as a source outpaces word of mouth, Facebook, Instagram and TikTok.

Black sports fans offer brands a new opportunity to turn fan loyalty into brand loyalty. For women's basketball, with Black talent like Angel Reese and A'ja Wilson attracting interest, viewership hit record highs. Between 2023 and 2024, Black viewership increased 161% for the WNBA All-Star Game, 227% for the WNBA Draft and 51% for the NCAA Women's Basketball Championship. This engagement is likely to drive sales: Black fans are 7% more likely than all sports fans to buy a brand after seeing its sponsorship activations.

His 163 career receptions and 2,375 receiving yards both rank fifth all-time in program history. He also finishes his Memphis career with nine games with at least 100 receiving yards, which ranks fifth in that category.



Alan Heinrich says Congress must stand up for inventors against deep pocket patent infringers

As a new Congress takes the reins, lawmakers are racing to tackle the mountain of legislation that awaits their attention.

Not every bill deserves to reach the president's desk. The innocuously named Litigation Transparency Act would make it harder for inventors to defend their patents in court. Since patents are the cornerstone of the high-tech economy, the bill would undermine our collective prosperity. Deep-pocketed corporations increasingly help themselves to the inventions of America's innovative small businesses. If small firms fight back, big corporations often engage in a drawn-out legal battle, using their vast resources to wear down the little guy.

Sadly, this strategy of "efficient infringement" often works. Filing and litigating a patent infringement lawsuit can cost millions. For a small startup without big financial reserves, this creates an almost insurmountable barrier to enforcing intellectual property rights.

Recently, some innovators have turned to financial firms for help funding infringement suits. This financial backing enables start"Courts are fully capable of balancing the need for transparency with the protection of privileged information and legitimate business interests..."

ups to press a lawsuit through to its conclusion -- and makes potential infringers think twice before trying to steamroll over others' intellectual property rights.

The Litigation Transparency Act wouldn't ban these funding arrangements outright. But, make no mistake, that will be the result. The Litigation Transparency Act would force small businesses to disclose financing agreements, potentially exposing a plaintiff's legal strategy. It would leave funders and their investors vulnerable to harassment campaigns and intimidation tactics. And it would lengthen legal proceedings with meaningless compliance arguments.

The source of funding for a lawsuit is ultimately irrelevant to the merits of the case itself. Regardless of who is financing it, the

bad actors and disadvantage already vulnerable inventors, enabling big corporations and nefarious foreign actors to walk all over American small businesses.

Legislation that hamstrings entrepreneurs from protecting their rights would deal a major blow to innovation. That's because smaller firms with under 10 employees receive nearly 60% more patents, per capita, than large corporations with 25,000+ employees.

The bill's proponents say disclosure is necessary to expose unethical or illegal funding arrangements. But existing court procedures and ethics rules already address such concerns.

In Taction Tech., Inc. v. Apple Inc., a California court showed existing rules can balance transparency and privacy. The judge limited what litigation funding information had to be shared. While some details could be disclosed, the court protected sensitive information, especially documents subject to confidentiality agreements. These were considered "protected work proSimilarly, in Trustees of Purdue Univ. v. STMicroelectronics N.V., a Texas court reviewed funding-related documents privately and decided they didn't need to be shared. The judge found these documents both irrelevant to the case and protected by legal privacy rules. Notably, the judge even described the litigation funder as more than just a money source, but as an entity providing important legal services.

Courts are fully capable of balancing the need for transparency with the protection of privileged information and legitimate business interests. A one-size-fits-all approach to disclosure, as proposed in the bill, is not only unnecessary but assuredly lethal to the rights of small businesses, and potentially harmful to the judicial process.

If we value innovation and justice, we should strengthen the ability of small inventors to enforce their rights, not hand more advantages to infringers.

U.S. Sen. Blackburn offers way Congress can stop the tragedy of human trafficking which soared to record heights under Joe Biden

Although shocking, this fact reflects a troubling reality: Human trafficking is one of the fastest growing criminal industries in the world—generating \$150 billion in profits— and afflicts every community in our country, including in Tennessee.

Through November of last year, there were 1,170 reports of human trafficking in our state, according to the latest Tennessee Bureau of Investigation (TBI) data. This number marks a significant drop from 1,432 reports in 2023, thanks in large part to the committed efforts of Governor Lee, the Tennessee General Assembly, and TBI to end this modern-day slavery. But unfortunately, it is still 62 percent higher than the number of reports recorded as recently as 2019.

While human trafficking has long been a problem in our country, this heinous crime became even more pervasive under the Biden administration, which for

four years surrendered our southern border to cartels, criminals, and traffickers. As a result, every state became a border state—and suffered the tragic consequences.

Just this month, authorities charged eight Venezuelan illegal aliens in Middle Tennessee for trafficking women across our border to be sexually exploited. The illegals, who conducted their criminal operation out of Nashville motels between 2022 and 2024, are tied to the violent gang Tren de Aragua, which has plagued cities across the country with rampant crime.

Tragically, all too often the victims of these traffickers are defenseless children. According to TBI data, there were 514 reports of minor sex trafficking in Tennessee in 2024, more than twice the number of reports of adult sex trafficking. The report also notes that there has been an increase in the number of unaccompanied minors who are trafficked into our country and exploited.

This should come as no surprise: Under Biden, hundreds of thousands of unaccompanied children reached our southern border, while many more arrived with adults who falsely claimed to be their relatives. Although the then-President had a responsibility to place these children with vetted sponsors, his administration lost

track of more than 320,000 migrant children who face the threat of abuse, trafficking, and sexual exploitation.

Thankfully, after four years of failure under the last administration, President Trump is working to secure our border, protect our communities, and bring human trafficking to an end—and there is so much Congress can do to support this effort.

Just last week [week of February 17], I introduced the bipartisan GRACIE Act, which would require the recording of all Child Protective Services interviews with children and adults. Although 60 percent of child sex trafficking victims in our country have engaged with the foster care system, too often CPS staffers miss signs of abuse. By recording interviews, we can increase the likelihood that child trafficking victims will be identified and removed from dangerous situations.

Last month, I also reintroduced a package of bills that will do so much to combat human trafficking. My SAVE Girls Act, for example, would provide states, local governments, and nonprofits with the resources they need to end the trafficking of young women and girls. My National Human Trafficking Database Act, meanwhile, would establish a national human trafficking database at the Department of Justice and incentivize state law enforcement agencies to report data.

To help bring an end to trafficking at the border, I also introduced the End Child Trafficking Now Act, which would require a DNA test to determine the relationship between illegal aliens attempting to enter our country and

any accompanying children. And my PRINTS Act would give Customs and Border Protection the authority to fingerprint noncitizens under the age of 14 to combat human trafficking and child recycling.

It is far past time that we brought the horrific practice of human trafficking to an end. With these bills, Congress can provide President Trump the tools he needs to make it happen.

Public Safety Institute (PSI) evaluates Memphis Police Department Gun Crimes Unit and examines gun violence

Gun violence places a substantial burden on families, communities, and government systems, including health and social services. National data reveal ongoing challenges in addressing gun-related crimes, with clearance rates for these offenses declining over recent decades. According to FBI Uniform Crime Reporting (UCR) data, in 2019, U.S. law enforcement agencies cleared 31% of aggravated assaults with firearms compared to 61% of homicides and non-negligent manslaughters. Some agencies clear as few as 10-20% of nonfatal shootings, despite nonfatal shootings being three to four times more common than fatal shootings. This distinction is critical, as victims and offenders in nonfatal shootings are at heightened risk for future lethal violence.

In June 2022, the Memphis Police Department (MPD) launched investigate nonfatal shootings and aggravated assaults involving firearms, excluding domestic violence cases.

Creation of a special unit to investigate gun-related aggravated assaults is part of the local Safe Community Action Plan. As part of its commitment to evaluate parts of the plan as they are implemented, the Public Safety Institute conducted an evaluation of the GCU, with Dr. James McCutcheon taking the lead.

The GCU's scope included incidents where victims were shot or shot at, often resulting in severe injuries. By June 2023, the GCU was absorbed into the Violent Crimes Unit (VCU). The evaluation's analysis of GCU's caseload from June 2022 to June 2023 showed significant fluctuations, with case volume peaking in May 2023 at 273 cases before dropping sharply to 135 cases in June 2023. While staffing levels remained relatively stable, arrest rates did not consistently correspond with case volume. Many cases remain unresolved due to resource limitations and challenges such as outstanding warrants and victim noncooperation. The evaluation concluded that improving clearance rates for nonfatal shootings requires sustained and strategic investigative efforts. Establishing specialized units like the GCU is a promising approach. Such units must be adequately staffed and resourced to address their higher caseloads. Research shows that nonfatal shooting units often manage workloads four times greater than homicide units. Enhancing

Unit, and the Multi-Agency Gang Unit could mitigate structural and logistical barriers. Gaps in communication and resource shortages can hinder efficiency.

The evaluation concluded that addressing these challenges through improved inter-unit coordination and strategic planning offers a pathway to strengthen the investigative process, reduce gun violence, and prevent future homicides.

PSI Studying Local Forensic Needs

phis team led by Dr. James McCutcheon, associate professor in the Department of Criminology and Criminal Justice, conducted a feasibility study for the city of Memphis on the possibility of a local forensics laboratory with the primary focus on the needs at the Memphis Police Department. The study assessed the current forensic infrastructure, operational processes, accreditation requirements, and potential costs on establishing a local lab. The study also examined potential actions that could be taken fairly quickly to improve current forensic processes and facilities, including investing in certain types of forensic testing such as rapid DNA testing, increasing the ability to properly transport evidence to the TBI lab in Jackson, and a potential agreement with the TBI to allocate resources and personnel dedicated to testing Memphis/Shelby County evidence.

Now, the Public Safety Institute (PSI) is undertaking a second phase of the local study, with Dr. McCutchen as senior research developer for the PSI taking the lead. The second phase is being funded by Shelby County.

Phase two of the crime lab feasibility study will shift its focus to the county level by conducting interviews with suburban police departments and the Shelby County Sheriff's Office to better understand their forensic needs and challenges. This phase is essential to building a comprehensive picture of regional forensic capabilities and ensuring any proposed solutions meet the needs of all stakeholders.

A rather significant focus of this phase will be on digital forensics. Given the growing importance of digital evidence in modern investigations, the PSI will explore current practices, limitations, and opportunities for improvement. Key areas of emphasis include:

1.Data Management and Storage: The study will assess how agencies are handling the storage and security of digital evidence, particularly sensitive material like child exploitation evidence. Best practices for maintaining data integrity and preventing breaches will also be identified. 2.Inter-Agency Collaboration: The PSI will explore opportunities for local law enforcement agencies to share resources or establish centralized digital forensic capabilities to reduce duplication and improve overall efficiency.

3. Training and Staffing: This phase will evaluate the level of training and expertise among personnel working with digital evidence. It will identify gaps and make recommendations for certifications or specialized roles to meet increasing demands.

4. Technological Infrastructure: The PSI will assess the technological tools and infrastructure currently available to suburban departments and the Sheriff's Office, including software, hardware, and network security, to determine what upgrades or investments may be needed.

By incorporating input from these other local law enforcement agencies as well as the Memphis Police Department, able recommendations that address both traditional and digital forensic needs. These findings will help guide the development of a sustainable and efficient county-level forensics system.

Other areas of focus in Phase two will include assessing the need to expand the use of rapid DNA testing and the resources necessary in order to achieve that.

were anti-Clarence Thomas and who labeled him Uncle Tom, etc. Little did I realize that I became the only Black editor to endorse Thomas for the Supreme Court. [As a side note, I was the only Black editor to have endorsed Donald Trump for President in the 2016 election. And yes, I had interviewed Hillary Clinton oneon-one just as I had Bill Clinton early on in his presidential bid). To reiterate, whenever I asked some of these civil rights leaders why they seemingly hated Thomas, their main response was that Clarence Thomas was a Republican. I later wrote that they hated Thomas because he was not part of the "Good Ole-Black Boy and Black Girl Network." Long story short, as editor I made the decision we would back Judge Clarence Thomas one-hundred per cent. As a newspaper editor, I believe once you take an editorial stand you go in all the way, especially when it is a decision of this historic magnitude. If I ended up on the wrong side of

How thrilled we were when Judge Clarence Thomas became Supreme Court Justice Clarence Thomas, becoming the second Black Supreme Court Justice. Later I received that one-on-one interview with Justice Thomas

when he came to Memphis for an event, U.S. Marshals escorted me to the back of the stage (This event took place at the historic Peabody Hotel). Justice Thomas was told that Newsweek and CNN wanted to interview him, and he politely said to the messenger: "No, Ms. Mitchell is the only one who will be interviewing me." He turned to me as I sat and said, "Ms. Mitchell, I know you don't always agree with me on everything, but you have been the only journalist who has ever been fair to me." This is what you want to hear as a journalist. Yes, I know I had the reputation of being called Miss Poison Pen along with a few other choice words in my career—but moving on. I later met Justice Thomas again. This time at the Supreme Court when I was in Washington, D.C. to accept an award from the National Foundation for Women Legislators, Inc. at the National Press Club. (When I look back, I note how small the world really is. Greta Van Susteren also received an award, but I don't believe she made it. I didn't see her on the dais where we recipients sat. Ms. Van Susteren was with CNN at the time and now she has her own show on Newsmax. It is among the best and few in old school journalism.)

I had a very pleasant time chatting with Justice Thomas and his wonderful secretary, Dorothy (and I apologize for not remembering her last name). A few years after the hearing, I had been invited to the White House to have luncheon with President George H.W. Bush in the Roosevelt Room, along with 12 other colleagues from around the country. I was seated directly across the table from Pres. Bush and sat next to then CIA Director Robert Gates. (A photo in Jet Magazine ran thereafter). All this is to bring us back to why we are saluting Newsmax this Black History Month. Some years back, we saluted the late Danny Thomas who founded St. Jude Research Children's Hospital. In our Black

History Month specials, we look at brain cells and not skin cells. We try to look at those who go against the grain. You should read it, because it is American History, and shows him to a man who is well worth his seat on the Supreme Court and place in history.



The 48th stamp in the Black Heritage series honors the legendary musician and songwriter Allen Toussaint (1938-2015). An icon of New Orleans music, Toussaint's contributions to rhythm and blues (R&B), jazz, and rock 'n' roll have left an enduring mark on American music. The first-day-of-issue event for the Allen Toussaint Black Heritage stamp was free and open to the public. It was held the George and Joyce Wein Jazz Heritage Center in New Orleans, Louisiana on January 30, 2025. News of the stamp was hared with the hashtags #AllenToussaintStamp and #BlackHeritageStamp.

On hand for the event were: Gary Barksdale, chief postal inspector, U.S. Postal Inspection Service ,and Quint Davis, chief executive officer, Festival Productions Inc.

Background:

Music icon Allen Toussaint's legacy continues to inspire. A prolific pianist, singer, songwriter, composer, arranger and producer, Toussaint left an indelible mark on New Orleans music and beyond. His legendary career spanned decades, producing countless hits and collaborations with a wide array of artists. From classic songs such as "Fortune Teller" and "Southern Nights" to his behind-the-scenes work, Toussaint's influence continues to resonate globally.

President Barack Obama recognized Toussaint with the National Medal of Arts in 2013. His previous honors include induction into the Blues Hall of Fame in 2012, the Songwriters Hall of Fame in 2011, the Louisiana Music Hall of Fame in 2009, and the Rock & Roll Hall of Fame in 1998. In 2022, the New Orleans City Council renamed Robert E. Lee Boulevard for Toussaint, who lived on the four-mile-long thoroughfare during the last years of his life.

Ethel Kessler, an art director for USPS, designed the stamp using a photograph by Bill Thompkins. The Allen Toussaint stamp will be issued in panes of 20. Forever stamps will always be equal in value to the current First-Class Mail 1-ounce price.

Nobody needs to tell African-Americans in this country that the old new deal from the Democratic Party isn't working for them. In election after

election, Democratic party leaders take African-American voters for granted and year after year the condition of Black America gets worse. The conditions in our inner cities today are unacceptable. Too many African-Americans have been left behind.

African-Americans need a new deal from their next president. Donald Trump is proposing just that. The following are ten promises announced by Donald Trump on October 26, 2016 in Charlotte, NC that will define a new deal for Black America:

1. Great Education Through School Choice. We will allow every disadvantaged child in America to attend the public, private, charter, magnet, religious or home school of their choice. School choice is the great civil rights issue of our time, and Donald Trump will be the nation's biggest cheerleader for school choice in all 50 states. We will also ensure funding for Historic Black Colleges and Universities, more affordable 2 and 4-year college, and support for trade and vocational education.

2. Safe Communities. We will make our communities safe again. Every poor African-American child must be able to walk down the street in peace. Safety is a civil right. We will invest in training and funding both local and federal law enforcement operations to remove the gang members, drug dealers, and criminal cartels from our neighborhoods. The reduction of crime is not merely a goal – but a necessity.

3. Equal Justice Under the Law. We will apply the law fairly, equally and without prejudice. There will be only one set of rules – not a two-tiered system of justice. Equal justice also means the same rules for Wall Street.

4. Tax Reforms to Create Jobs and Lift up People and Communities. We will lower the business tax from 35 percent to 15 percent and bring thousands of new companies to our shores. We will also have a massive middle class tax cut, tax-free childcare savings accounts, and childcare tax deductions and credits. We will also have tax holidays for inner-city investment, and new tax incentives to get foreign companies to relocate in blighted American neighborhoods. We will empower cities and states to seek a federal disaster designation for blighted communities in order to initiate the rebuilding of vital infrastructure, the demolition of abandoned properties, and the increased presence of law enforcement.

5. Financial Reforms to Expand Credit to Support New Job Creation. We will have financial reforms to make it easier for young African-Americans to get credit to pursue their dreams in business and create jobs in their communities. Dodd-Frank has been a disaster, making it harder for small businesses to get the credit they need. The policies of the Clintons brought us the financial recession – through lifting Glass-Steagall, pushing sub-prime lending, and blocking reforms to Fannie and Freddie. It's time for a 21st century Glass Steagall and, as part of that, a priority on helping African-American businesses get the credit they need. We will also encourage small-business creation by allowing social welfare workers to convert poverty assistance into repayable but forgive-able micro-loans.

6. Trade That Works for American Workers. We will stop the massive, chronic trade deficits that have emptied out our jobs. We won't let our jobs be stolen from us anymore. We will stop the offshoring of companies to low-wage countries and raise wages at home – meaning rent and bills become instantly more affordable. We will tell executives that if they move their factories to Mexico or other countries, we will put a 35% tax on their product before they ship it back into the United States.

7. Protection from Illegal Immigration. We will restore the civil rights of African-Americans, Hispanic-Americans, and all Americans, by ending illegal immigration. No group has been more economically-harmed by decades of illegal immigration than low-income African-American workers. Hillary's pledge to enact "open borders," – made in secret to a foreign bank – would destroy the African-American middle class. We will reform visa rules to give American workers preference for jobs, and we will suspend reckless refugee admissions from terror-prone regions that cost taxpayers hundreds of billions of dollars. We will use a portion of the money saved by enforcing our laws, and suspending refugees, to re-invested in our inner cities.

8. New Infrastructure Investment. We will leverage public-private partnerships, and private investments through tax incentives, to spur \$1 trillion in infrastructure investment over 10 years, of which the inner cities will be a major beneficiary. We will cancel all wasteful climate change spending from Obama-Clinton, including all global warming payments to the United Nations. This will save \$100 billion over 8 years. We will use these to help rebuild the vital infrastructure, including water systems, in America's inner cities.

9. Protect the African-American Church. We will protect religious liberty, promote strong families, and support the African-American church.

10. America First Foreign Policy. We will stop trying to build Democracies overseas, wasting trillions, but focus on defeating terrorists and putting America First.
