## Trump, Letitia James, and Your Property

At one time in this nation if you wanted to vote, you had to own property.

Property. Vote. Keep these two words at the top of your brain cells while I go into this excursion on how what is happening to President Donald Trump and his properties in New York City is a prototype of a political party’s ‘right’ to take your property Under the Color of the Law without Due Process if they don’t like your politics. New York State Attorney General Letitia James can sit in court and break every law in the book to destroy you and take your property, especially if you are “too white, too pale, and too male.” Her sidekick, Judge Arthur Engoron, can be openly blatant and discourteous because he does not answer to the voters who put him office. He, like Letitia ‘Jessie’ James, answers to the Democratic Party, a party which has, as it was in the Old South, become the exclusive party in New York City. If you think about it, New York City's justice system is reminiscent of that same Jim Crow system where judges, attorney generals, DAs, and prosecutors could openly boast of their verdicts well before a trial. These judges and those connected with the law had no problem in signaling that they were going to release the murderers of Emmett Till, the Three Civil Rights Workers (in Philadelphia, Mississippi), and other victims. The trials were kangaroo courts. These judges did not give a damn because they had a mainstream media pushing the Jim Crow power agenda of the southern Democratic Party establishment which was "segregation then, segregation now, segregation forever" as voiced by Gov. George Wallace. Just as Judge Engoron is doing, they felt emboldened to even boast that they were judge and jury in the lynching of anybody whose politics they did not like or the color of anybody's skin they did not like. That color of skin has now become 'white'. So, does that make it right any more than it did when it was black? Morality and ethics should transcend politics, but in New York's judicial system, it does not. It is a system which has gone WOKE with retaliatory discrimination inflated with the forced subjugation of its citizens and of its property owners. If you think what New York's radical judicial system has invoked only applies to President Trump and Trump family members, you are wrong.

The key factor to control the 'wealth of a nation' is the ability to confiscate (steal) property 'Under the Color of the Law' and to invent so-called 'legal' avenues to redistribute that confiscated property through fraudulent conveyance to their cronies and elite party members. Trump and his properties have to be made the example if they are to put FEAR in any property-owner and ultimately into any citizen (voter) who dares to question them. George Soros-soaked James and her sidekick judge are attempting to steal President Trump's property and strip him and his family of ever doing business in New York which has now morphed into America's quasi-socialist/Marxist model with a population that has turned its head and its back on common sense. Letitia James and Judge Engoron have used Under the Color of Law to devalue Trump's Mar-a-Lago, his historic American property in Florida. Never mind Letitia 'Jessie' James and her sidekick judge have yet to question Joe Biden's homestead mansion and the history of how he appraised his properties. For some insight, all one has to do is read pages 48-51 of Miranda Devine's "Laptop from Hell" to see Biden's manipulation to gain access to what Devine describes: "...Joe had bought a Du Pont mansion of his own in 1975, when he was a thirty-two-year-old recently widowed senator on a salary of \$44,600 per year." (page 49).

Controversies on Biden's property buying continue, as Devine elaborates when she writes the following on page 49 about another Biden mansion which he "dubbed the Station": "...He sold it twenty-one years later, in 1996, for \$1.2 million, in circumstances that would later attract controversy. The buyer of the house was John Cochran, the vice president of MBNA, the Delaware credit card giant that would give Hunter his first job. Journalist Byron York looked into the house sale for the *American Spectator* after it was raised as an issue in Joe's 1996 reelection campaign."

One wonders how Biden could afford his properties. But it does not take Sherlock Holmes to figure out that Biden's property buying in the millions seemingly jells with Biden

confiscating classified documents when he was a U.S. senator. But if you are stealing classified documents while you are a U.S. senator and later a U.S. vice president, who knows how you are fattening your bank account to obtain your historic and other properties? But then, again, maybe those Chinese ‘dollars’ helped him out with mortgage payments. Looks like some good prima facie evidence to me.

Devine also writes about Hunter Biden acquiring a Du Pont property (page 48). The Du Pont property is historic, just as Mar-a-Lago. Both are not in New York. But the Bidens get a get-out-of-jail pass.

If Letitia ‘Jessie’ James and her legal eagle thugs succeed, who is to say that 10 percent will not be put away for “the Big Guy” and some other Big Guys when they ‘redistribute’ Trump’s properties—Trump’s wealth—and property of others without Due Process and Under the Color of the Law? Not only can they steal property, but can gag you from talking about it, violating your right to free speech. Eventually, you will also be denied the right to own your own business without the State’s permission or rather the Democratic Party’s permission just as in any socialist Marxist regime.

I shall say what I have in the past: Joe Biden is a classic segregationist which means that it is his modus operandi to play one group against the other— to pit white against black--to pit the oppressed against the oppressor—to pit “regular whites” against what he has labeled “MAGA white extremists.” This is the same playbook the Democratic Party of the 1860’s and 1960’s used. As a veteran journalist and in the history of my life, I have witnessed the deterioration of journalism. With the exception of a handful, the media is the catalyst in legitimizing the Democratic Party-backed outlaw Attorney General Merrick Garland and Judge Engoron in outright stealing property and violating citizens’ First Amendment and Constitutional rights. One has to wonder how large of a shareholder Emperor George Soros is in legacy media companies—but that’s another story. Moving on. And speaking of moving, with this move to confiscate Donald Trump’s property, including the Trump Tower and Mar-a-Lago (in Florida), the Democratic Party is implementing the same tactics and tricks it did to take black-owned properties after the Civil War all the way into the 21<sup>st</sup> Century. Just ask black farmers about that! Specifically black male farmers. After all, the classic segregationist has often made the black male and black male property owners his point of attack.

Already, Biden has reneged time and again on his promise to protect black farmland. This is why John Boyd Jr., a black male, founder, and president of the National Black Farmers Association (NBFA) has stated that he and his organization will not endorse Biden. In a press release from May 2023, Boyd stated: “... I have repeatedly urged to no avail President Biden to honor his commitments to us and those thousands of Black, Native American and other farmers of color who are being forced into bankruptcy and foreclosures.”

We recently dove back into our archives where we supported years ago Boyd’s fight to preserve black farmland. (This was from our 2004 archives.) We ran the NBFA lawsuit and

editorials to let a community know that once you are stripped of your property and property rights and you fail to weaponize your vote and punish mostly those Democratic so-called lawmakers (law-breakers) who did it, you are pretty much over and done with. The taking of Trump's properties is yet another escalation into stealing black-owned property be it farm or be it church or be it house or be it a rotting shack in the middle of nowhere. Politics becomes a pliable excuse to steal at will without penalty such as in the case of Letitia 'Jessie' James who operates in the mode of the typical so-called 21<sup>st</sup> Century Black elite leader who can do no more than bitch and march to acquire votes for the Democratic Party. James is also the prototype of the same elite black trash who gets power and plunges everyone into Third-World dependency. Their steps might as well be the stomping of a black political sorority or fraternity. You know (pat your feet): Bitch, bitch, march, march, bitch, bitch, bitch!

Now that I have been nice about that, let me do continue in a much nicer way:

In our archives, we also found reference to a 2015 lawsuit, which originated from the Obama administration and focused exclusively on 'Black male' farmers to strip them of their property. That lawsuit alleged that Black male farmers were being blocked from funds. The lawsuit cited: "...[T]he Claims Administrator (a contractor for the USDA) has sent letters to all Black male claimants since 2013, stating among other things the following: 'Thank you for your interest in the Hispanic and Women Farmers and Ranchers Claims Resolution Process. To participate in this Process, you must be either Hispanic/Latino or female. On your claim Form, you indicated you are an African American Male. As a result, you are not eligible to participate in this Claims Resolution Process, and your claim has been DENIED'."

Which means, Black males, you better visit that Hood called Man.

The Democratic Party in its policies and jurisprudence mob knows that it can be blatant and disrespectful in denigrating the Black male because as Joseph 'Stalin' Biden put it, "if you don't vote Democrat, then you ain't Black." (That denigration now extends to practically all males regardless of race or color—but I shall get back to that issue at another time for I have not the space to expound).

The Democratic Party is again tying property ownership to politics.
